**Austin, TX – December, 18, 2014** – Travis County District Clerk Amalia Rodriguez-Mendoza announced today her office can now accept uncontested divorce filings prepared electronically via *TurboCourt*<sup>™</sup>, the newest e-filing service provider for Texas courts. Currently, this application is only available for filing in the Travis County District Courts and will soon be available throughout the state of Texas.
